MEMORANDUM OF UNDERSTANDING

Shooting Sport Opportunity Development on Colorado's Front Range

This MEMORANDUM OF UNDERSTANDING (MOU) is hereby made and entered into by and between

1. Federal Agencies: For purposes of this MOU the federal agencies are:
 - a. United States Department of Agriculture –
 - i. Forest Service (USFS):
 1. Arapaho –Roosevelt National Forests, Pawnee National Grassland, and
 2. Pike- San Isabel National Forests, Comanche and Cimarron National Grasslands,
 - b. United States Department of Interior –
 - i. Bureau of Land Management (BLM)
 1. Royal Gorge Field Office,
 - ii. Fish and Wildlife Service (FWS)
 1. Mountain-Prairie Region (specific to Colorado)
2. State Agencies: For purposes of this MOU, the state agencies are:
 - a. Colorado Division of Wildlife (CDOW),
 - b. Colorado State Parks (CSP)
3. Private Organizations: For purposes of this is this MOU, the private organizations include the following (in alphabetical order):

4. The parties (federal agencies, state agencies, and private organizations - cooperators/ partners) to this MOU are referred to collectively as the Colorado (Front Range) Shooting Sports Opportunity Development Workgroup.
 - a. The Primary mission for the Forest Service and the Bureau of Land Management is multiple use management of the federal lands they administer. Under the multiple use mandates of the Forest Service and Bureau of Land Management, shooting sports activities (defined for purposes of this MOU to include activities conducted at target ranges and appropriate dispersed shooting sites) are legitimate uses of those lands, except where specifically prohibited for safety or other legitimate reasons.
 - b. Fish and Wildlife Service authorizes public uses that are appropriate and determined to be compatible with the mission of the National Wildlife Refuge System (NWRS) and the primary purposes of the individual refuge. FWS supports and encourages hunting and fishing and actively participates in target range development on lands through the FWS Division of Federal Assistance. Under that program, financial grants and technical assistance are provided to the states to build and improve target ranges.
 - c. Based upon Colorado Wildlife Commission Policy B 15.5, which is available for review at <http://wildlife.state.co.us/NR/ronlyres/A9932562-23E0-4AC7-8D99-AD48798F2C9F/0/PolicyB155ShootingRanges.pdf>, the Colorado Wildlife Commission and the CDOW support the establishment of shooting ranges and endorse appropriately located dispersed recreational shooting opportunities that provide opportunities for hunter education and for hunters to practice their shooting skills.
 - d. A brief description of each agency and private organization (cooperator/ partner) that is a signatory of this MOU is contained in Appendix A.

*** **

A. PURPOSE:

1. The purpose of this MOU is to develop and expand a framework of cooperation among federal, state and local partners for enhancing shooting sports opportunities in a safe and environmentally sound manner along the Front Range of Colorado.³

B. FACTORS INFLUENCING MOU CREATION:

1. There are multiple current factors impacting the need for this MOU. Some, but not all, of the more pertinent factors include the following:
 - a. Colorado's Front Range population is approximately 3,931,163 people (81.8% of the state's population) and, urban development and encroachment have limited or eliminated many recreational shooting opportunities on federal, state, county, community and private lands on the Colorado Front Range. Increased public demand for multiple forms of outdoor recreational use including increased recreational shooting necessitates that public land manager's review perceived impacts on the land from all forms of outdoor recreation.
 - b. Historically, organized and dispersed shooting opportunity along much of Colorado's Front Range was served by public lands (local, community, county, state and federal) and/ or private shooting ranges. Rising land values due to urban development, urban encroachment, real or perceived liability and issues/perceptions regarding safety from some surrounding residents have all contributed to the reduction of both developed and undeveloped dispersed recreational shooting opportunities.
 - c. The cooperators of this agreement emphasize the necessity for local, state, and federal level public involvement to resolve emerging recreational shooting sports issues. Shooting sport activities and associated projects complement the mission of the cooperating partners and serve the mutual interests of the partners and the public.

³ For purposes of this MOU, Colorado's Front Range is defined to extend from Wyoming to New Mexico and the primary focus area consists of 15 counties as follows: Larimer County, Weld County, Denver County, Adams County Arapahoe County Broomfield County, Douglas County, Jefferson County, Boulder County, Gilpin County, Clear Creek County, El Paso County, Teller County and Pueblo County Colorado as well as all State Wildlife Areas and State Parks within these counties and all lands administered by the US Forest Service Pike - San Isabel National Forests, Comanche and Cimarron National Grasslands, by the Arapaho - Roosevelt National Forests, Pawnee National Grassland and by the Bureau of Land Management Royal Gorge Field Office.

C. STATEMENT OF MUTUAL BENEFIT AND INTERESTS:

1. The partners have established a multi-agency – community based partnership as an umbrella for activities and solutions that will provide for shooting sports in balance with other recreation uses and public safety. Working together as partners, we encourage local level analysis and a public involvement process to address recreational shooting issues.
2. The private organizations encourage shooting sports activities on federal and state agency lands and on other appropriate public and private lands and desire to provide assistance in connection with access, construction, and improvement of ranges as appropriate and consistent with the Non-Fund Obligating Document section of this MOU.
3. Front Range federal, state and local partners have common interests that include:
 - a. Increasing sustainable public opportunities for recreational and sport shooting, and
 - b. Enhancing those opportunities in a safe and environmentally sound manner, and
 - c. Providing leadership opportunities in quality environmental stewardship specific to outdoor shooting ranges, and
 - d. Providing safe recreational shooting opportunities under a low maintenance managed operation format, or by providing for dispersed recreational shooting opportunities.
4. Mutual benefits include but are not limited to:
 - a. Providing public access to federal, state and other public and private lands and enhancing opportunities where appropriate on federal, state and other public and private lands to engage in shooting sports activities, and
 - b. Promoting safe shooting opportunities while maintaining public safety, and
 - c. Promoting marksmanship, hunter and shooter education, competition, lawful hunting, public demonstrations, outdoor recreation, and responsible land stewardship, and
 - d. Developing opportunities to collaborate with additional potential partners to provide complementary resources for shooting range development, and

- e. Working with local communities to develop continuing relationships that will provide the oversight necessary to insure the viability of the shooting ranges that are developed.

D. OBJECTIVES:

1. Objectives of this partnership are to:
 - a. Identify and assess potentially appropriate federal⁴ and state agency locations and other locations as appropriately identified for safe, environmentally and economically self sustaining shooting ranges and other appropriate dispersed recreational shooting opportunities,
 - b. Develop local partnerships to construct, improve and manage a wide range of shooting opportunities,
 - c. Establish on-going communication, education and ethics programs on safe and environmentally sound shooting sport and shooting sport opportunities.

E. COOPERATORS SHALL:

1. Perform outreach activities, share interpretive and educational materials regarding enhancing shooting sports, communicate and recruit understanding and support for enhanced shooting sports opportunities along Colorado's Front Range.
2. Assess potential suitable locations for development of shooting ranges.
3. Organize and host a series of community-based forums along Colorado Front Range to facilitate cooperative relationships and local partnership formation. Local forum partnerships will work together to:
 - a. Identify local needs,
 - b. Assess local opportunities and
 - c. Develop continuing local relationships and interactions that will sustain local oversight necessary to insure the viability of the shooting ranges that are developed,
4. Work towards shared web-based technologies (including the Colorado Division of Wildlife's website and the Colorado State University's

⁴ Any shooting range developed on RGFO administered BLM land will need to be authorized through either the R&PP Act and proceed to patent, or through direct sale of the land involved. Either way, the land to be developed would then be owned and managed by someone other than BLM.

- "Landhelp" website) to provide maps and information on safe and environmentally sound recreational shooting sport opportunities.
5. Research successful models and case studies from around the country that have implemented a wide range of shooting sports opportunities and/or successfully mitigated unacceptable shooting sport situations.
 6. Work together to develop a funding strategy to support partnership MOU objectives and support local efforts.
 7. Coordinate programs designed to mentor youth on the enjoyment of and respect for shooting sports, hunting and recreation use of public lands.

F. AUTHORITY

 - a. Fish and Wildlife Coordination Act (16 U.S.C. 661 *et seq.*)
 - b. Fish and Wildlife Act (16 U.S.C. 742(f) *et seq.*)
 - c. National Wildlife Refuge System Administration Act of 1966 (16 U.S.C. 668dd-668ee)
 - d. The National Wildlife Refuge System Improvement Act of 1997 (P.L. 105-57)
3. **United States Department of Agriculture - Forest Service**
 - a. Organic Administration Act of 1897 (U.S.C. 551)
4. **Colorado State Division of Wildlife**
 - a. 33-1-105(1)(c), C.R.S., Powers of Commission: Construct or otherwise establish public facilities and conveniences at any site or on any land in which the commission holds an interest and operate and maintain all such lands, facilities, and conveniences and provide services with respect thereto, and, when appropriate, make reasonable fees or charges for their use or enter into contracts for their maintenance or operation;
 - b. 33-1-105(1)(e) C.R.S., Powers of Commission: Enter into cooperative agreements with state and other agencies, educational institutions, municipalities, political subdivisions, corporations, clubs,

landowners, associations, and individuals for the development and promotion of wildlife programs;

5. Colorado State Parks

- a. 33-10-107 Powers of Board (1) the board (Board of Parks and Outdoor Recreation) has power to: (d) Enter into cooperative agreements with state and other agencies, educational institutions, municipalities, political subdivisions, corporations, clubs, landowners, associations, and individuals for the development and promotion of parks and outdoor recreation programs.

G. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. FREEDOM OF INFORMATION ACT (FOIA) AND COLORADO OPEN RECORDS ACT:

- a. Any information furnished to the federal agencies under this instrument is subject to the Freedom of Information Act (5 U.S.C. 552).
- b. The Colorado Open Records Act (TITLE 24 - ARTICLE 72) applies to the state, its agencies, institutions and political subdivisions as defined therein and any document(s) provided thereto are generally available for public inspection unless the document(s) is/are specifically excluded from such inspection provision.

2. PARTICIPATION IN SIMILAR ACTIVITIES. This instrument in no way restricts the federal agencies, the state agencies, or the cooperator(s) from participating in similar activities with other public or private agencies, organizations, and individuals.

3. COMMENCEMENT/EXPIRATION/TERMINATION. This MOU takes effect upon the signature of the each cooperator and shall remain in effect for five years from the date of execution. This MOU may be further amended upon written request of any one or more of the cooperators and the subsequent written concurrence of the other(s). Any one or more of the cooperators may terminate their MOU participation with a 60-day written notice to the other(s).

4. RESPONSIBILITIES OF PARTIES.

- a. Each cooperator and their respective agencies and office will handle their own activities and utilize their own resources, including the expenditure of their own funds, in pursuing these objectives. Each

party will carry out its separate activities in a coordinated and mutually beneficial manner.

APPENDIX A - brief description of each agency and private organization. . .

Colorado Backcountry Hunters and Anglers is the Colorado affiliate of a national all volunteer organization that shares a common bond: A passion for the forests, mountains, prairies and waters that support our chosen way of life. CBHA believes in keeping public lands healthy and accessible and promoting programs and activities that support our common bond. We believe in protecting the big, natural areas and natural functions that support our hunting and fishing heritage. We share a concern that the peace, quiet and freedom that make hunting and fishing special may be lost to the pressures of human population, industry and technology. We come together to protect our outdoor traditions and make sure future generations enjoy the high-quality outdoor experiences we grew up with.

Colorado Bowhunters Association is an organization originally formed in 1969 and is dedicated to the use and preservation of all legal archery equipment used in Colorado hunting. CBA: encourages and perpetuates the sport of bow hunting, cooperates with and support federal and state agencies, sportsmen's' associations, and conservation organizations, which are insuring the propagation and preservation of game and its natural habitat; encourages and conducts educational programs designed to acquaint the public and the archer with the safe and ethical use of the bow for hunting and bowhunting as an effective method of hunting legal game; and fosters unity and perpetuates the spirit of good fellowship among bowhunters.

Colorado Mule Deer Association is a nonprofit organization that is dedicated to maintaining and increasing the population of Colorado mule deer. CMDA is actively involved in an advisory capacity to the Colorado Legislature, the Colorado Division of Wildlife and the Bureau of Land Management.

Colorado State Division of Wildlife is the state agency responsible for managing wildlife and its habitat, as well as providing wildlife related recreation. The DOW is funded through hunting and fishing license fees, federal grants and Colorado Lottery proceeds through Great Outdoors Colorado.

Colorado State Parks is the state agency responsible for managing State Parks and regulating various forms of outdoor recreation. CSP is funded through the sale of entrance fees to state parks, snowmobile, OHV and boating registration fees, through grants, bequests and trusts, through general funds and Colorado Lottery proceeds provided directly and through Great Outdoors Colorado.
